## Warneford developments update

Becky had been chasing agreed follow-up to the RA chairs' meeting with OBMHT, without success. Planning Officers have said that the applications won't go to SDCC on 28 March and probably not on 25 April. The valuation of the meadow has been under investigation: Hansard had reported is as £30.9m, a 2005 strategic health authority board paper quoted £10-15m. FOWM are investigating ownership of the meadow and mitigations for proposed destruction of parts of the orchard and wildlife corridor.

#### **Foundation Trust membership**

OBMHT have written to the association to ask it, or individual residents?, to join. Becky will write for clarification and offer distribution to all residents if the Trust produce a suitable

letter. Discussion of whether to boycott or treat as a separate issue from Warneford developments. Decided to treat as separate, to keep communication channels open in the longer term.
