1. Latest on planning

Application to register Warneford Meadow as a town green

The Town Green Inquiry, which reconvened on January 18th and lasted for six days, has been adjourned again until 19 May and is expected to go on for another three days. Friends of Warneford Meadow raised over £3,500 at their Charity auction, but still need to raise another £2,000 to reach the final £37,000-target. Golf course - reprieved?

The City Council's executive have approved a revised draft of the Core Strategy which proposes new areas of the City for development. There will be a six-week consultation beginning on 7 March. The main change is the inclusion of a proposed major Southern Development Area south of Greater Leys (how this can be integrated into the City's transport network isn't made clear). The draft also (para 1.3) drops proposals to develop on Southfield Golf Course, at least for now, because of 'ecological and hydrological constraints'. HTRRA will respond to the consultation. 2. Latest on Controlled Parking Zone (CPZ)

After consultations throughout East Oxford at the end of 2007, the County Council is now giving priority to a Divinity Road area CPZ. From their website: 'Subject to available funding, which is to be agreed as part of the capital programme at the Cabinet meeting on 18 March, we will be consulting local residents and stakeholders with a view to developing a CPZ in the Divinity Road area of Oxford during 2008/09. We will be looking to develop CPZs in the other parts of East Oxford as soon as possible after this, although this is subject to confirmation of funding and resources within the transport programme.'

After a recent fire, the Golf Club has written to the Council about the implications of the street's congested parking for access for emergency vehicles. The Club, with our agreement, is pressing for speedy introduction of parking restrictions.

3. Police matters

The local police are aware that there has been a higher than normal number of what they term 'nuisance' burglaries in the neighbourhood recently, such as theft of small items from sheds. They are pursuing this actively, and would welcome reports of any incident, however small, that might prove relevant. Community support officers are visiting all local roads daily, including Hill Top Road and Southfield Park flats, both as a deterrent and to alert residents to possible break-in points that could be better secured.

There have also been increased incidents of car vandalism. Again, the police are aware and would appreciate reports of all acts of car vandalism so they can investigate this fully. It is particularly important that residents bother to report damage to their cars as there has been the suggestion to the police from a non-resident that damage is part of a campaign to harass non-residents who park here.
